THESE TRIPS GENERALLY CONSIST OF VOLUNTEER PROJECT TEAMS THAT INSTALL SOLAR POWER SYSTEMS - CONNECTING SCHOOLS, MEDICAL CLINICS, COMMUNITY CENTERS, ORPHANAGES, WATER-PUMPING STATIONS, AND CHURCHES TO A 30-YEAR SUPPLY OF SUSTAINABLE ELECTRICITY.
