THIS CHALLENGE IS ESPECIALLY EVIDENT IN COUNTRIES WHERE THE OVERWHELMING NEEDS OF SCHOOLS, MEDICAL CLINICS, ORPHANAGES AND CHURCHES FAR EXCEED THE CAPACITY OF PUBLIC INFRASTRUCTURE.
