Mission Trips: SonLight Power annually sponsors mission trips that impact children and their families living without access to reliable electricity. These trips generally consist of volunteer project teams that install solar power systems - connecting schools, medical clinics, community centers, orphanages, water-pumping stations and churches to a 30-year supply of sustainable electricity. Applications powered by Sonlight solar projects include lights and multimedia tools to improve education, refrigeration to store food and life-saving vaccines and medicines, and water-pumping where clean water is scarce. Over the lifetime of SonLight's collaborative projects, the solar power generated makes an immediate and lasting impact for tens of thousands of lives.
